

DAHLSSENS SOUTH COAST REGION BUILD & ESCAPE PROMOTION

TERMS AND CONDITIONS

The Dahlsens South Coast region Major Prize Draw promotion (hereafter referred to as the Major Prize Draw) is administered and run solely by Dahlsens Building Centres Pty Ltd (ABN 30 005 032 333) (hereafter referred to as Dahlsens or the Promoter).

Information on the Prizes and how to enter form part of these Terms and Conditions. Entries not completed in accordance with these Terms and Conditions are ineligible. Participation in the Major Prize Draw constitutes acceptance of these Terms and Conditions.

Employees of the Promoter and related entities of the Promoter are ineligible to enter.

Suppliers and business affiliates of the Promoter are ineligible to enter.

The Promotion Period runs from 6.00am AEST Monday 12 May 2025 to 5.00pm AEST Monday 11 August 2025.

Trade Account Holders will receive one (1) entry into the Major Prize Draw for the first \$15,000 (including GST) of new orders and invoiced sales accumulated on their Dahlsens Nowra Trade Account during the Promotion Period.

Or, Trade Account Holders will receive one (1) entry into the Major Prize Draw for the first \$15,000 (including GST) of new truss and frame orders accumulated during the Promotion Period at Dahlsens Ulladulla Truss and Frame and delivered to projects located within the Shoalhaven and up into the Thirroul–Broulee–Bowral–Moss Vale regions, including all areas in between.

Note: items ordered before the beginning of the Promotional Period, for delivery within the Promotion Period are not eligible.

Bonus entries

Trade Account Holders will be awarded one (1) entry for every additional \$5,000 (including GST) of new orders and invoiced sales accumulated on their Dahlsens Nowra Trade Account during the Promotional Period.

Trade Account Holders will also receive one (1) entry for every additional \$15,000 (including GST) of truss and frame ordered at Dahlsens Ulladulla Truss and Frame, accumulated during the Promotional Period for delivery to projects located within the Shoalhaven and up into the Thirroul–Broulee–Bowral–Moss Vale regions, including all areas in between.

All orders and sales must occur during the Promotion Period to qualify.

Each entry is owned by the Trade Account and the subsequent principal of the Trade Account (Trade Account Holder).

All transactions on cash sales or C.O.D. transactions are excluded from eligibility to enter. The Promoter has the right to refuse entry, and no correspondence will be entered into.

It is the responsibility of Account Holders to ensure all contact details are correct and up to date with Dahlsens. This includes postal address, phone, fax number and email address.

MAJOR PRIZE DRAW

The Major Prizes are 2 x \$15,000 travel vouchers valued at a total of \$30,000 (including GST).

The Minor Prizes are 3 x \$1,000 Visa Gift Cards valued at a total of \$3,000 (including GST).

The Major Prize Draw is expected to start at approximately 7.00pm Wednesday 20 August 2025 at the Dahlsens Nowra Trade Night, Nowra Golf Club, Fairway Drive, North Nowra.

The Promoter will make every attempt to contact the winner of the Prizes from the contact details provided on the winning Trade Accounts. Should incorrect details be provided, the Promoter will conduct a re-draw at the time of being unable to contact the initial winner.

There will be two Major Prizes drawn, chosen at random from all eligible entries received. Any Account Holder who has already won a prize on the evening of the draw will be ineligible to win a second prize on the evening. The Promoter's decision is final and no correspondence will be entered into.

To be eligible to win a Prize, the Entrant or an approved representative of the Entrant must be in attendance at the Major Prize Draw, Dahlsens Nowra Trade Night Wednesday 20 August 2025 – held at Nowra Golf Club, Fairway Drive, North Nowra.

To be eligible to win a Prize, the Entrant must be within terms at the time of the Prize Draw and not on hold or suspension.
